## COLLOQUIUM 2012 ERIN CULLIN

The second annual Northeast Continuing Professional Development Conference was held in Sudbury on October 25th and 26th, 2012.

Dubbed “Colloquium” by the organizing committee, the Conference was once again a rousing success, attracting lawyers not only from Sudbury, but also from Timmins, North Bay Sault Ste. Marie, New Liskeard, Nobel, and Toronto.

Thanks to the diligent efforts of the organizing committee and the session leaders, Colloquium offered programs over a wide spectrum of disciplines, ranging from Family Law, Criminal Law and Civil Litigation to Administrative Law, Corporate Law and Estates Law. The roster of speakers was impressive, and included well-known speakers on the legal lecture circuit as well as several prominent members of the Bench. Rounding out the speakers’ list were several SDLA members and lawyers from surrounding communities.

Those in attendance at the Evidence Law session on Thursday were treated to a surprise guest appearance when the Conference’s keynote speaker, Justice Ian Binnie, joined in a lively discussion with the panel.

The spotlight shone on the judiciary during three illuminating speeches on Thursday and Friday. On Thursday afternoon, Sudbury native and former SDLA President, Justice Robert Maranger, delivered a fascinating speech about his involvement as the Judge hearing the infamous Shafia case in Kingston. On Thursday evening, keynote speaker retired Supreme Court Justice Ian Binnie, amused the large dinner crowd with his observations about the evolution of legal practice.

On Friday afternoon, the SDLA, in conjunction with the University of Sudbury and the University of Ottawa Faculty of Law, sponsored a one-on-one discussion with retired Supreme Court Justice Louise Charron.

Following the dinner on Thursday evening, the SDLA hosted a well-attended hospitality suite, giving the attendees an opportunity to mingle and to meet their colleagues from throughout Northeastern Ontario and beyond. Rumor had it that festivities continued into the wee hours of the morning.

Special thanks goes out to Lucille Shaw, Chair of the Organizing Committee, and Justice Patricia Hennessy, both of whom were key players in spearheading and organizing the conference. We also would be remiss if we didn’t acknowledge the behind-the-scenes work by Rannah Sopha and the staff at the Sudbury District Law Library; their support was essential to the success of the Conference.

Preparations are already underway for Colloquium 2013, which will be held on October 17th and 18th 2013. Mark your calendars—you won’t want to miss it!

### TRAVELS IN LAW EDWARD J. CONROY

I had the good fortune to be part of the World Bar Association Conference in Edinburgh. Ever since I have combined travel with law when I can.

The rule of conduct re gowns limits the wearing of gowns to "the courts and their environs." The rule pertains in England and though not widely used there are public through fares within the area encompassed by the Bailey, the said law courts and the Inns of the Court in London. At 75 feet of area Elm Street is the "environs."

If you are "doing" this area of London beneath your feet are the Silver Vaults, well worth while; down the narrow (4 feet) Devereaux Lane at the end you find Devereaux's Inn, one of the best for food.

In Paris, the Superior Courts are on the Isle de Paris, the ancient concierge, loosely translated "the kitchen." I fell in with some French barrister's about 11:45 a.m., they told me their courts ran from noon to six p.m. with a 15 minute break. So 5 hours and 45 minutes, not too different from our "day in court." They completed my education by wondering how anyone after a night on the town could get going much before noon.

Southampton is the English port which normally is the situs for all crimes of the high seas. Winchester is the county town. There is an interior wall of the Winchester Court House, a "round table" reminiscent of King Arthur. Quite charming.

In attending court one morning I was patted down, quite unusual in those days. The officer explained it was a "traffic matter." I expressed surprise at the Roads Traffic Act. He explained that this "traffic" was a shipload of machine guns destined for the I.R.A.

Also at Winchester Court I saw the tail end of a murder trial. About 10 counsel at the table. The totally circumstantial case proved the accused had taken tea with the deceased. There were no other suspects.

I watched painstaking pleadings, cross examination clearly proving the deceased was a "neat nick" not only washing up the minute one finished one's tea, but almost before one finished. In the sink there were three cups used. Quere who the third person was. The Crown withdrew the information.

## **EIGHT COUNTRIES IN FOUR DAYS**

Imagine....cycling through eight countries in four days—interacting with the indigenous population; hearing their language; eating their food; and without once suffering the indignity of a security check or the malaise of jet lag. Well you can...I did... and it's called Toronto.

Toronto is one of the most cosmopolitan cities in the world. It is arguably *the most* cosmopolitan city in the world. In its 2006 census, Statistics Canada reported that 49.9% of Toronto's residents were born in foreign countries, making it more ethnically diverse than New York City. Toronto celebrates its ethnic diversity with such enclaves as China Town, Corso Italia, Little India, Greek Town, Korea Town, Little Jamaica, Little Portugal and Roncesvalles.

This multi-culturalism has proven to be a treasure trove for food blogger Sara Efron, a Toronto journalist committed to searching out authentic hole-in-the-wall restaurants and strip mall eateries serving food from all corners of the world. Add to this the fact that the City of Toronto is relatively bike friendly and you have the makings of a cycling trip around the world, particularly if, like me, you have relatives living in diverse parts of our provincial capital.

So day one has me setting out from my mother-in-law's condo in Pickering with the home of my sister-in-law in Maple being

my ultimate destination. It is a distance of 50.7 kilometers, which allowing for side trips and getting lost, is about the distance between Tim Horton's on Lorne Street and Tim Horton's in McKerrow. On the way my first stop (for lunch) is Japan.

J-Town is located at 3160 Steeles Ave. East in Markham. It is in the largest Japanese mall in the Greater Toronto area. It contains Japanese shops and restaurants. The vendors are Japanese; the patrons are Japanese and the food is Japanese. The lingua franca is Japanese. For an hour and a half I was back in Tokyo. On offer is everything Japanese — from magazines and clothing to green tea and groceries—and of course the ubiquitous sushi. At the Café Green Tea, I choose breaded pork washed down with a can of coffee which one finds everywhere in Japan in vending machines.

With a side trip to pay a surprise visit to an aunt and uncle living in Thornhill, it is off to Trinidad. At Drupati's Doubles & Roti Shop, I have the largest serving of goat roti I have had in my life—so much so that I saved part of it for breakfast the next morning, after hunkering down at the home of sister-in-law Donna for the night. Going from Japan to Trinidad in one day can be quite a trip.

On day two, it is off to Plaza Latina for lunch. Plaza Latina is the equivalent of J-Town Mall except it has grocery stores and restaurants from Central and South America.

There are two Ecuadorian places, La Fuente Del Puro Saor which is a juice bar where they make fresh juice from papaya, melon, orange, sour sop and other fruits, and Comedor Popular & Ecuatorina which serves up fried beef empanada and sopas de gallina (hen soup). And they have Inca Cola on tap. The mall also has Chilean, Columbian and Cuban eateries. Apparently on Sunday afternoon it is impossible to get a

parking spot because the food court is crammed.

Supper tonight will be in Brazil. Getting to Brazil involves a bike ride along the Humber River. Who knew? At Segovia one may sample Brazil's national dish, which consists of black beans cooked with pork, smoked bacon and chorizo and is served with rice, collared greens, toast cassava flour, torolo salsa and orange slices. This night I will “bed and breakfast” with my daughter Jennifer and three granddaughters in Roncesvalles.

It is day three and I am off to the home of another daughter Allison located in Greek Town. My route takes me along the glorious 56 kms. Martin Goodman Trail which hugs the north shore of Lake Ontario. Lunch is in China at the all day Dim Sum King eatery on Dundas Street West. Supper takes me to Afghanistan and the Banmian Kabob with Allison, her husband Costin, and the “gingerboy.”

The lamb kabob is truly amazing with lettuce salad and the place is packed with Muslim families in traditional dress, with wide smiles brought on by good food.

Day four and it is to the Philippines we go for breakfast. To stop at the Ritz Diner is to step back into the 1950's. There are table-side juke boxes and a clientele of Filipinos along with others enjoying the Filipino breakfast in which you get to choose between Tapisilog (pieces of marinated beef); Dangsilog (marinated fish) and Longanisa (a type of sweetened sausage) to go with your poached eggs and garlic sticky rice. Of course we order all three.

Lunch this day will be in Malaysia where I am joined by son Adam and his lovely and talented girlfriend Aisling Rose Forde. Gourmet Malaysia serves up Malaysian, Singaporian and Indonesian food. I had been blown off course by heavy down winds and Adam and Aisling were good enough to pre-order.

The food was delicious and we topped it off with "ais kacang" which is a desert made of crushed ice sweetened with syrup along with strings of jelly, salted peanuts, creamed corn (!) red beans and sweet basil seeds which taste like tapioca.

Arriving back in Pickering, I find that I have cycled 222.7 kilometers which at the same time gives you the appetite to eat and drink as much as you want.

Eight countries in four days!
