## GOLF 2010

### Inside this issue:

The latest edition of the Sudbury District Law Association Annual Golf Tournament was held at Cedar Green on Friday, August 13th, 2010. Despite the ominous potential associated with the date, nevertheless, the stars and sun aligned to provide perfect weather for an afternoon of golf, and 48 members took advantage by participating in this year's event.

This number is actually lower than past years, and many individuals who would have been considered as "regulars" failed to attend. In light of the day's activities, including the ideal weather, the obvious joie de vivre and camaraderie among the participants, aided by the odd libation dispensed by the "cart girls", the excellent steak dinner and the vast array of prizes handed out at the end of the day, it truly is a mystery why more members of the association do not take part.

Turning to the results this year, Damien Buntsma won the tournament, shooting a sparkling 75, to register his first win at this event. Unfortunately for Damien, he was scheduled to leave Sudbury within a week of his victory, to take up a new job in Ottawa. Damien has promised to return to Sudbury next August to defend his title.

Some controversy did arise concerning the disposition of the winner's trophy between events. Tradition has permitted the winner to retain the trophy, however, in light of Damien's victory, a hastily convened meeting of the SDLA golf executive passed an emergency by-law decreeing that the trophy was required to remain within the territorial jurisdiction of the District of Sudbury, and a compromise was therefore reached whereby Damien agreed to keep the winner's hardware in the Weaver, Simmons trophy case.


It should be noted that during the past winter, to ensure that the next winner would not be really anxious to put the trophy up for display, Berk Keaney managed to destroy several parts of the magnificent bauble, emblematic of golf supremacy, purchased and donated Leo Arseneau, and then presented it on the day of the tournament, with pieces reattached in a very temporary and precarious condition, using silly putty. He also failed to have his own name as last year's winner engraved on the trophy, so that if Damien wants his winning to be properly displayed, whether in Sudbury or in Ottawa, he is going to have to spend

The donor of the winner's trophy, Leo Arseneau, blew himself out of the competition, taking a 9 on hole number 6, by losing his first two drives, and going 5 off the tee on that particular hole.

Once again this year, there was no individual victor on the women's side, Carol Hartman once again abstaining, and so far, no other woman stepping forward to assume the mantle. Carol did however show up for the après-golf cocktails and the meal, apparently intent on promoting her political agenda, even though by then, the dinner featuring Mr. Ignatieff, which had been scheduled for the following Sunday, had in fact been cancelled.


The first prize on the women's side was in fact presented to an entire foursome, both in connection

I look forward to seeing everyone on Monday October 4th. I can indicate at this time we are losing at least 2 bodies from last year. Damien Buntsma has left for Ottawa. Trevor Kestle has fractured a knee cap and is out of commission likely for the complete season. This means if everyone who played last year returns, we would only have 14 players, so if there are any other individuals interested, please provide me with their names and we can see how many we can accommodate.


